

Horace City Council Meeting Minutes

The Horace City Council met on September 16, 2019 @ 6:00pm at Horace City Hall. Those present were Kory Person, John Koerselman, Chelsey Johnson, Bryan Schmidt, Lukas Croaker, Jim Dahlman, Brenton Holper, and Matt Lower.

Mayor Peterson called the meeting to order.

The Pledge of Allegiance was recited.

Agenda Item #3: Approve Regular Agenda

Motion: Approve the regular meeting agenda.

Action taken: All in favor, none opposed. Motion carried.

Agenda Item #4: Approve Consent Agenda

Agenda Item #6: Public Comment

William Ziglar, a resident of Horace, express concerned on proposed property tax increases.

Dave Gronlie, a resident of Horace, wanted clarification on the tax increase with the Horace Park

District. Council identified that they are a separate entity and taxing authority. The Council encouraged

Mr. Gronlie to attend the Park District meeting for more information.

Agenda Item #7: FY 2020 General Fund Budget

Discussion: Mr. Holper presented the FY 2020 General Fund Budget with revenues and expenditures. Change in home/property valuation was roughly 6.3%. The cities change in proposed budget was roughly 7% and the exact increase outside of valuation, at .76% increase.

Public hearing: A public hearing was opened at 6:15pm and closed at 6:19pm. Mr. Gronlie commented on the budget expenditures for average salary compared to Fargo and West Fargo, information is not known. Also commented on 20K line item for equipment purchases, and professional services.

Discussion: Mr. Schmidt would like to see a 0% increase, even though the proposed increase is minimal. The level of detail in the proposed budget is much greater and thorough than in past years.



Mr. Holper mentioned the increase in the building permits line item is largely due to the new High School building. Mr. Holper also pointed out an increase in the city's budget is also tied to sharing state aid with the Park District and Fire District entities for a total of \$44,000 total. Expenditures and revenues can be lowered by \$7K to make the best effort to the keep the mill the same.

Motion: Motion to approve the final budget with noted change to lower by \$7K with Mr. Holper's

recommendations.

Agenda Item #8: Becher Variance

Discussion: Mr. Lower presented details on the variance application. Planning commission recommends an approval on the variance.

Public hearing: A public hearing was opened and closed at 6:30pm with no comment

Motion: Motion to approve Becher Variance.

1st Motion: Councilmember Johnson2nd Motion: Councilmember Schmidt

Action taken: All in favor, none opposed. Motion carried.

Agenda Item #9: Prairie View 2nd Addition

Discussion: Mr. Lower presented the Park Board subdivision application for Prairie view 2nd addition that would entail dividing it into five separate lots. The planning commission met and recommended denial of the application for the reason that no Park Board representative was present at the meeting. **Public hearing:** A public hearing was opened at 6:33pm and closed at 6:35pm. Don Dabbert spoke against the proposal as amended covenants does not allow for lot splits and the current design plan is not part of the developer's agreement. Mr. Croaker commented that Mr. Dabbert owns over 20% of the lot area, and under the city ordinance if over 20% of the landowners oppose, then the city would need ¾ of the landowners to approve the development.

Motion: Motion was made to table for further discussion with Park Board and developers.

Action taken: All in favor, none opposed. Motion carried.

Agenda Item #10: Parking Ordinance No. 2019-07, & Block Length - 1st Reading

Discussion: Mr. Lower went over the parking ordinance as it stands now, allows for the developer to request a reduction in parking minimums by using a parking generation manual that is published by the institute of traffic engineers. The planning commission recommends we adopt the same language and tool that West Fargo uses that allows developers to use The Urban Lanes Institute Shared Parking manual. A more scientific tool for parking minimums that is well received across the region.

Public hearing: A public hearing was opened and closed at 6:44pm with no comment.

Agenda Item #11: Railroad Right-of-Way (ROW) Land Purchase with West Fargo School District

Discussion: Mr. Holper presented details on BNSF property near Lakeview Dr., roughly 22,113 sq. feet. WFSD has authorized staff to move forward on purchasing railroad right-of-way. However, an additional right-of-way is of interest to the City Council as a right-of-way for Lakeview Drive and a benefit to the Horace High School in proximity. Cost for the land estimated at \$0.63/sq.

Motion: Motion to proceed with negotiations for right-of-way with West Fargo School District and BNSF for the railroad property west of the school's property from the water tower to 81st Ave. South.

Action taken: All in favor, none opposed. Motion carried.

Agenda Item #12: Engineering/Public Works

Discussion: Mr. Dahlman provided an update on shared use path will be starting late this week, early next week. Lights are temporarily connected to the roundabout, not on yet permanently due to rain delay, working on feed point.

Agenda Item #14: City Administrator

Discussion: Mr. Holper provided an update on the North Dakota League of Cities conference held Thursday (9/19) and Friday (9/20) in Bismarck. Communications Specialist position has been filled with Shelby Wheeler. Mosquito spraying scheduled for Wednesday (9/18) and is weather dependent. Partners in Marketing grant and working on a community map for different neighborhood designation, a great marketing tool for the city.
